

- Rank 14 out of 73
- One of 133 out of 354passed written and oral bar exam in Massachusetts in 1942
- Admitted to the Massachusetts bar while in uniform, 12 October 1942

- RI Delegate to National Association of Women Lawyers Meetings




- 1948- wins under new RI primary law

- Graduate of respected law school
- Exemplary service in the armed forces during World War II
- Member of state and federal bar
- Elected to local and state public office four times



Champion of Rights and Progress for Women


- Presidential Commission on the Status of Women 1961, advocated equal pay for equal work
- Study to establish the Family Court of RI
- Founding Mother of National Association of Women Judges
- Paved the way for two dozen women judges in RI

First Woman Supreme Court Justice in RI

- After 22 years as Trial Court Judge (1956-1978), Murray was appointed by Governor J. Joseph Garrahy to the Supreme Court of RI
- From 1979 to 1996 she served as the first woman jurist on the highest court
